

The President of the Republic of Ghana, H.E Nana Addo Dankwa Akufo-Addo has been elected Chairman of the Economic Community of West African State (ECOWAS)

At the 57th Ordinary Summit of the Authority of Heads of State and Governments which took place on 07 September 2020 at Mahatma Gandhi International Conference Centre in Niamey, Niger Republic, President Akufo-Addo took over from President Mahamadou Issoufou of Niger and will serve for a term of one year.



The Secretariat of the African Continental Free Trade Area (AfCFTA) has officially been opened in Accra, Ghana, a major milestone in the full implementation of the free trade agreement.

A flagship project of the African Union's Agenda 2063, the African Continental Free Trade Area creates a market of 1.2 billion people with a combined GDP of \$3 trillion.

Trading will begin in Jan 2021 and President Akufo-Addo announced that provision would be made for a residential accommodation to serve as the official residence of the Secretary General of AfCFT.


In 2018, the Oriental Republic of Unuguay assigned him the position of Honorany Consul in Ghana.

## BILATERAL PROJECT (Development and Manufacturing Support by Our Members) - Elmina Fishing Harbour



The President of the Republic, Nana Addo Dankwa Akufo-Addo, on Thursday, 20th August 2020, cut the sod for the commencement of construction of the Elmina Fishing Port and Landing Site project that is with funding from Belgium.

According to President Akufo-Addo, when the Elmina Fishing Port project is completed, it will provide a big boost for the fishing industry in Elmina, especially as the fishing industry is an important sector of the country's economy.

"In all, the Project will, first, see to upgrading existing facilities such as the administration building, the slipways, workshop, and the maintenance dredging of the existing Port. Secondly, the Project will also include the construction of a new fishing harbour, with a main breakwater and a quay wall to enable larger fishing vessels to safely moor and offload, a dedicated access road to the Port, and a warehouse for storage," The President revealed.

The President added that the project will contain other works comprising the construction of an additional administrative building; a shed for the fish market; a shed for fishing net mending; two (2) Cold Stores/ Ice factories; a new slipway for bigger vessels with a boat re- furbishment area; a toilet block; and a day care centre. The Project will also provide beach and coastal protection works, as well as restoration of the area in front of the Elmina Castle, to enhance tourism.

## President Akufo-Addo Cuts Sod For Construction Of Wenchi Water Supply Project

According to President Akufo-Addo, "it was in 2002, under the Government of the 2nd President of the 4th Republic, His Excellency John Agyekum Kufuor, that the existing Wenchi Water Supply System, with funding from the Government and the European Un- ion, was constructed, as part of the Small-Town Water Supply Schemes embarked upon at the time." The existing Water Supply System is based on ground water obtained from mechanised boreholes, and supplies water only to the Wenchi Municipality. An assessment carried out by the Ghana Water Co.Ltd. indicated the poor state of the existing system, and the recommendation was for a new Water Supply System, which will abstract water from fresh water sources, ensure continuity of water supply, and meet the everincreasing demand for water in the catchment area. To execute this project, the Akufo-Addo Government has secured a thirty million-euro (€ 30 million) credit facility from Belfius Bank of Belgium, with the support of the Belgian Export Credit Agency, Credendo.

After its completion, in thirty-six (36) months, the total supply capacity will be ten thousand, seven hundred (10,700) cubic meters per day, which will be adequate to meet the year 2040 water demand for an estimated population of some ninety-two thousand five hundred (92,500) people in towns such as Wenchi, Droboso, Yoyoano, Beposo, Asuano, Koase, Nkonsia, Wurompo and Awisa.

"Plans are far advanced for construction of the Greater Kumasi Metropolitan Area Water Supply Project in the Ashanti Region, Kpong Phase II Water Supply Project in the Eastern Region, Tarkwa Water Supply Project and Sekondi- Takoradi Water Supply Project in the Western Region, Techiman Water Supply Project in the Bono East Region, Sunyani Water Supply Project in the Bono Region, and Assin Fosu Water Supply Project in the Central Region, which will all provide water in response to the rising demand for water in these areas," he added.

## **Takoradi Roads Construction**



Parliament has approved a €72m facility aimed at financing the construction of the Paa Grant Interchange and other roads in the Sekondi-Takoradi township.

The project is expected to enhance economic activities and improve public transport and the standard of living of the residents.

The Paa Grant roundabout is one of the three roundabouts that link the peripheral roads which form a triangular ring road and adjoining roads within the central business district of the Sekondi-Takoradi metropolis.

It attracts significant traffic into the area but has limited traffic capacity, resulting in poor network performance, which impacts commercial activities negatively.

The roundabout is located to the east of the triangular network and is a key access point for inter-city traffic between Sekondi and Takoradi as well as port traffic to the port gates 1 and 2.

The proposed intervention includes road

widening, pavement strengthening, interchange and junction improvement, footbridge and railway overpasses, street lighting facilities, and pedestrian facilities.


Moving for the adoption of the Finance Committee's report on the financing facility, chairman Dr. Mark Assibey-Yeboah said the Ministry of Finance has requested Belfius Bank SA/NV to structure an Export Credit Facility with support from Credendo, Belgium, to finance the project at an estimated contract sum of  $\in 65$ m.

On his part, the Western Regional Minister, Kwabena Okyere Darko-Mensah, said the project is aimed at improving traffic circulation by enhancing the capacity of the road network, removing bottlenecks, and improving the movement of people, goods and services to support socio-economic development of the inhabitants of Sekondi and Takoradi. The successful implementation of the project is expected to result in lower vehicle operating costs, savings in travel time leading to savings in fuel consumption, and reduction in accident rates.

## DIPLOMACY IN TIMES OF COVID-19

The COVID-19 pandemic certainly shook up many of the orthodox structures and accelerated 180degree changes and embraced innovation. Diplomacy and multilateral systems were no exception. Against this backdrop, Consuls in Ghana face multiple challenges which encompassed;

- A Broad Range Of Elements,
- Including Access To Adequate Technology,
- The Re-Shaping Of Communication Protocols,
- The Need To Continue Their Work In
- Virtual Negotiation Settings.



#### **Virtual diplomacy**

Technological platforms have made it possible for members of the HCCGH to continue discussions and advance the multilateral agenda across the Ministry of Foreign Affairs and more broadly, the international community. Feedback from members often referred to how representatives from larger and smaller delegations had to gather in front of their screens, and found themselves negotiating in a whole new environment, one that is evolving at a very rapid pace. Often at times HCCGH members did not have the possibility of consulting with their capital-based experts as the negotiation periods continued to gets shorten. Different time zones and the lack of systems that provided for simultaneous interpretation have also hindered the participation of technical experts, academics, the civil society, the private sector, and other representatives that are based outside multilateral hubs.

Members are now required to think on their feet and oftentimes react on the spot to new proposals and developments as meetings have been reduced to address a much more prioritised agenda and within shorter time frames. In this sense, we are probably witnessing the surge of a specialised diplomacy, one that requires further technical knowledge and boosted innovative thinking.

Nonetheless, it has become clear that delegations from the developing world are underrepresented in virtual gatherings. Not only are governments focused on tackling the pandemic back home, but non-effective access to technology and the lower numbers of personnel have negatively impacted their engagement in the digital realm.

#### The role of the Governments

There is no doubt that the Government of Ghana undertook a tremendous amount of work during the time of crisis. In this context, the HCCGH members are responding to a more dynamic environment, with their role becoming more salient as permanent missions are called to engage with specialised agencies in the search of solutions to the health crisis, to further promote international co-operation, and to participate in the reactivation of commerce. In other words, there is a need to keep the momentum going for multilateralism, as we all have asserted that Ghana is not safe until all countries are, and global responses must show us the way to recovery.

#### Inclusiveness

On the other hand, and almost overnight, HCCGH members have been asked to become advanced users of virtual platforms. As stated before, challenges such as the gap in digital skills, meaningful connectivity, and other matters pertaining to the digital divide, may have placed participants from the African continent in a disadvantageous position. However the millennial generation, which currently constitute as supportive staff of many member consuls have ensured continuity of oper-ations.

As the HCCGH looking for ways to increase the efficiency and optimisation of regular procedures, while respecting established protocols and developing blended mechanisms in a sort of hybrid diplomacy, we should not forget that inclusiveness, transparency, and a broader participation of all states must be guaranteed. Moreover, the multilateral system is debating over the identification of situations in which virtual diplomacy mechanisms are feasible, without losing sight of conferences and meetings where physical presence and human interaction remain irreplaceable. In this regard, the meetings of groups of governmental experts come to mind, as they usually demand a higher degree of technical expertise and interactive discussions.

In terms of participation, the inclusion of all multistakeholders must be addressed. Effective access of all interested parties to multilateral decision-making processes, in face-to-face and virtual settings, will certainly amplify the opportunities for results and outcomes to produce greater impact.

#### **Forward-looking reflections**

As the pandemic continues to intensify the social, economic, and environmental crises, we will probably bear witness to reductions in financial and human resource allocations for diplomatic hubs, coupled with increased demands. It will then be natural to streamline our resources as we navigate through these unchanted and unpredictable waters.

On the upside, virtual meetings will allow for reduced travel budgets, especially as travel restrictions remain in place in many parts of the world, and as hybrid settings will permit the continuation of multilateral discussions and dialogues. Notwithstanding, there may also be a need for improved access to technological tools and working methods. HCCGH memers may benefit from broadening their skill set, among others, through improved digital capabilities and experience in virtual negotiation rooms. In the end, multilateralism and diplomacy will continue to play a key role in tackling the pandemic, while the promotion of increased trust and co-operation will be fundamental pillars of the global response to our shared challenges.

## **VISIT TO GA MANSTE**



On 23rd September 2020, members of the Diplomatic Corps in the country last Monday paid a courtesy call on the Ga Mantse, King Tackie Teiko Tsunu II, at the Ga Mantse Palace at North Kaneshie in Accra. The visit was to strengthen the relationship between the diplomatic community in Ghana and the Ga Traditional Council for their mutual benefit.

The Dean of the Diplomatic Corps, Mrs. Claudia Turbay Quintero, led the group, which included representatives of some international organisations in Ghana, such as the United Nations Educational, Scientific and Cultural Organisation (UNESCO) and the African Union (AU).

In the company of the visiting delegation were a Deputy Minister of Foreign Affairs and Regional Integration, Mr. Charles Owiredu, and the Founder and Leader of the Worldwide Miracle Outreach, Rev. Dr. Lawrence Tetteh.

Also present were a member of the Council of State, Mr. Stanley Nii Adjiri Blankson; the Otublohum Mantse, Nii Dodoo Nsaki II; the Dzaasetse of the Ga Stool and Principal Kingmaker, Nii Dr. Tetteh Kwei II, and the Sempe Mantse, Nii Adote Otintor II. The visiting envoys were treated to a display of the rich Ga tradition and culture.

#### Collaboration

Mrs. Quintero, who is also the Colombian Ambassador to Ghana, said effective collaboration between traditional authorities and the Diplomatic Corps could become part of bilateral programmes of the diplomatic community.

She thanked King Teiko Tsum for hosting the delegation and said the invitation was an expression of his commitment to serve as an agent of development.

"We acknowledge your influence and power within the traditional culture of Ghana where you preside over approximately four million people," she said.

She also said the visit offered a unique opportunity for the envoys and representatives of the international organisations to get closer to the traditional leadership, adding: "I am sure that those of us who find it possible to support some of the initiatives of the traditional authority will do so accordingly, and eventually we can create cooperation programmes to become part of the body of bilateral activities among our countries and Ghana."

Mrs. Quintero further said the visit marked the beginning of the establishment of a friendly dialogue between members of the Diplomatic Corps and the Ga Traditional Council. The visiting envoys made individual presentations to the traditional council.

#### **Girl-child Education**

King Teiko Tsum highlighted the importance of girl-child education to the development of the Ga State.

"Our goal is basically to improve the transition of girl-child education from junior high school (JHS) to senior high school (SHS)," he said.

According to him, the Ga Traditional Council, which he chairs, also intended to fund the training of girls in entrepreneurial skills in the area. He said there was the need to establish a technical committee to define a clear path on girl-child education.

King Teiko Tsuru further called for support from the Diplomatic Corps to improve salt mining activities in Ada, cattle ranching in Sege, aquaculture and real estate development.

#### Commitment

For his part, Mr. Owiredu reaffirmed the commitment of the government to work together with traditional leaders for the accelerated development of the country.

He thanked members of the Diplomatic Corps for extending courtesy to the traditional authority and described the move as a strategic partnership that would yield dividends for both the corps and the Ga State.
